1. I/we agree to provide a healthy, stable, loving and safe environment for the rescue dog, preferably until the dog is adopted into a permanent home.
2. I/we agree to provide needed medical care for the dog as needed, including vaccinations and heartworm checks/prevention. Great Creatures will reimburse foster homes for vaccinations and heartworm checks if needed.
3. If the dog should happen to bloat, we suggest you have the dog put down as it will tend to recur and Great Creatures cannot afford the medical treatment. If you have the dog treated for bloat/gastric torsion, it will be at your expense.
4. I/we agree to keep the dog as a house pet, at your residence, never to be left outside unsupervised. The dog must also sleep indoors at night.
5. I/we understand that Great Creatures reserves the right to evaluate the living conditions of the dog at any time and I/we agree to surrender the dog if said conditions are not found to be satisfactory.
6. I/we agree not to sell, trade, abandon, or dispose of the Irish Wolfhound in any way, but to notify Great Creatures if you cannot keep this dog as a foster.
7. I/we agree that I/we have homeowner's personal liability insurance coverage in an amount of \$100,000/\$300,000.
8. I/we agree that the dog remains the property of Great Creatures until such time as it is adopted. If I/we choose to adopt this animal, I/we understand that I/we must go through the entire adoption process (including filling out an adoption application and signing the Terms of Adoption) and will owe fifty percent (50%) of the adoption fee.

9. I/we agree to aid Great Creatures by allowing potential adopters to visit the dog in my/our home or at a place suitable to adopters, or allow the dog to be taken to another location to meet potential adopters.

10. I/we agree that one of the purposes of a foster home is to help determine the adoptability of each dog. Therefore, it is my/our responsibility to help assess its behavior towards men, women, children (those under ten years of age and those over 10 years of age), other dogs, and cats, where possible, In the event that problem behavior is noted (e.g., unprovoked or unpredictable/unmanageable aggression), I will notify Great Creatures within 48 hours of the observed incident so that Great Creatures can determine an appropriate course of action for the dog.

11. I/we, the undersigned, hereby specifically and forever release, discharge and hold harmless Great Creatures, its agents, and any other person, firm or corporation charged or chargeable with liability, their heirs, administrators, executors, successors and assigns, from any and all claims, damages, costs, expenses, loss of service, actions and causes of action belonging to the said persons fostering this Irish Wolfhound, arising out of any act or occurrence from the present time onward, and particularly on account of the fostering of the Irish Wolfhound described above.
